- 2. Both Fern Park and The Inlet Golf Course are groomed and have been groomed when snow was available.
- 3. The kitchen furniture from the cottages is being refinished and the task is about half complete, bringing the chairs and tables back to their original historic beauty.
- 4. The Parks Department is now seeking an employee to fill a vacancy that we have for a part time or full time employee.
- 5. The Inlet School will be using the Ice Rink on Mondays starting Jan. 5<sup>th</sup>. Every attempt will be made to make good ice at 10:30 PM on Sunday evenings to help in that effort.
- 6. The sledding hill lights are now, back on as the hill is now safe for sledding.
- 7. The Parks Dept. staff will have a new schedule as soon as all coverage can be made with the one full time staffer and the Parks Supervisor. There may be a few additional hours of Overtime for Frank Able to fill the void on Saturdays in January for a four or six hour shift if there is a snow event.

RESOLUTION NO: FRANCHISE AGREEMENT

On a motion offered by Councilman seconded by Councilman, the following resolution was ADOPTED by VOTE:

WHEREAS, an application has been duly made to the Board of the Town of Inlet, Hamilton County, New York by Time Warner Cable, Northeast LLC ("Time Warner Cable"), a limited liability company organized and existing in good standing under the laws of the State of Delaware ("Grantee") doing business at 120 Plaza Drive, Suite D, Vestal, New York, 13850 for the approval of an initial agreement for Time Warner Cable's cable television franchise for fifteen (15) years commencing with the date of approval by the Public Service Commission. The Franchise Renewal Agreement would bring the franchise into conformity with certain provisions of the Federal Cable communications Policy Act of 1984. As amended, and certain court rulings, AND

WHEREAS, a Public Hearing was held on January 6, 2015, at 8:00pm in the Town of Inlet and notice of said hearing was published in the Weekly Adirondack, on Friday, January 2, 2015, NOW

THEREFORE, the Board of the Town of Inlet finds that Time Warner Cable has substantially complied with the material terms and conditions of its existing franchise and with applicable law, has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached and that Time Warner Cable can reasonably meet the future cable-related community needs and interest, taking into account the cost of meeting such needs and interest, SO BE IT:

FURTHER RESOLVED, that the Board of the Town of Inlet hereby grants the cable television franchise of Time Warner Cable in the Town of Inlet for fifteen (15) years commencing with the date of approval by the Public Service Commission and expiring fifteen (15) years hence, AND

BE IT FURTHER RESOLVED, that the Board of the Town of Inlet hereby confirms acceptance of this Franchise Renewal Agreement.
